Subject: Budget Schedule for Fiscal Year 2024 City Council Budget Meetings

The Mayor will release the Proposed Fiscal Year 2024 (FY 24) Budget before the charter deadline of August 2, 2023. The City Manager will present the Proposed FY 24 Budget to the City Council in a Budget Hearing on Tuesday, August 1, 2023 at or after 3:00 p.m., along with a presentation of the FY 24 Capital Improvement Plan. The City Council must adopt the budget no later than 15 days prior to the end of the current fiscal year (September 15), at which time the Mayor will have an additional five days to review the Adopted Budget. The Mayor, at that time, may concur or exercise a line-item veto of any expenditure. The City Council has until the end of the fiscal year to concur with the Mayor's changes or override the veto.

The schedule of the upcoming FY 24 Budget hearings and Budget meetings is listed below. These meetings and hearings provide opportunities for review and discussion of the specific recommendations contained in the City Manager's Proposed Budget, the Mayor's Budget Recommendations, and the Budget Oversight Committee's recommendations, if any.
